### 2. 用途

證券持有人的個人資料可就下列目的持有 及處理:

- 處理 閣下的申請及退款支票及電子 自動退款指示(如適用)、核實是否符 合本申請表格及招股章程載列的條款 和申請程序以及公佈香港發售股份的 分配結果;
- 遵守香港及其他地區的適用法律及法規;
- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓證券;
- 存置或更新本公司證券持有人的名册;
- 核實證券持有人的身份;
- 確定本公司證券持有人的受益權利, 例如股息、供股和紅股等;

- 向本公司或H股股份過戶登記處提供 與其各自業務運作有關的行政、電訊、 電腦、付款或其他服務的任何代理、 承辦商或第三方服務供應商;
- 聯交所、證監會及任何其他法定監管機關或政府部門或法例、規則或法規 所規定者;及

# 4. 個人資料的保留
